TNS - Pilot Program - 2021

After meeting over the last 3 months for 5 fruitful online training sessions, we have a stellar group of 25 Lead Stewards! We received a lot of interest in the Lead Steward program for this year's Pilot Program – exciting prospects for future years as we plan for expansion. Our Lead Stewards have been busy completing homework assignments and getting familiar with their "Adopt-a-Patch" sites by conducting site walks, preparing site assessments, and creating stewardship plans.

2021 Pilot Sites: in accordance with COVID-19 guidelines, we have begun stewardship at the following 8 sites (*see map on next page*).

- Ashbridge's Bay Park (Ward 19)
- Glen Stewart Park (Ward 19)
- Sherwood Park (Ward 15)
- Roxborough Parkette N (Ward 11)
- Northline (Ward 19)
- Birkdale Ravine (Ward 21)
- The Middle Mill (Ward 14)
- Cherry Beach (Ward 14)

Activities include litter pickup, removal of garlic mustard, dog-strangling vine, Japanese knotweed, burdock, monitoring and more.

Pilot Program - Status of City Discussions

TNS drafted a Scope Document which was reviewed and agreed to by the City. It outlines the terms and agreements of the 2021 Pilot Program.

- The role of the City in the Pilot program includes:
 - Reviewing and approving sites and activities
 - Providing input on TNS proposed best management practices

 - Reviewing site assessments
 - Providing one-point person for contact and communication throughout the season

Manual Update: public and private

The current draft of the public manual continues to be tested in-field during the pilot program. Feedback and learnings are being recorded in anticipation of an updated document.

Significant progress is being made in developing a manual for private landowners of ravine land. Thank you to so many of you who have contributed thus far with legal, technical and plain old common sense.

Learnings from case studies of private properties on ravine land continue to be integrated into this draft of the manual.
